**ARTICLES OF MERGER  
OF  
CHURCH OF THE NAZARENE OF BEAVERTON AND  
EDEN COMMUNITY CHURCH OF THE NAZARENE  
WITH AND INTO  
THE FIRST CHURCH OF THE NAZARENE OF PORTLAND, OREGON**

The First Church of Nazarene of Portland, Oregon, an Oregon nonprofit religious corporation with members, the surviving corporation in a merger effected pursuant to ORS Sections 65.481 through 65.504 (the "**Merger**"), submits the following articles of merger for filing (the "**Articles of Merger**").

1. The names and types of entities proposing to merge are the Church of Nazarene of Beaverton, an Oregon nonprofit religious corporation with members ("**Beaverton Nazarene**") and Eden Community Church of the Nazarene, an Oregon nonprofit religious corporation with members ("**Eden Community Nazarene**") (each, a "**Terminating Corporation**" and collectively, the "**Terminating Corporations**"), with and into The First Church of Nazarene of Portland, Oregon, an Oregon nonprofit religious corporation with members ("**Portland Nazarene**" or "**Surviving Corporation**"). Beaverton's Oregon Registry Number is 030745-15. Eden Community Nazarene's Oregon Registry Number is 1090866-94. The Surviving Corporation's Oregon Registry Number is 012483-19.
2. The Terminating Corporations will merge with and into the Surviving Corporation, with the Surviving Corporation being the survivor of the merger.
3. A copy of the Plan of Merger ("**Plan of Merger**") is attached as Exhibit A.
4. The Articles of Merger and Plan of Merger were duly approved in accordance with ORS 65.487 by the directors of the Surviving Corporation, and were duly approved by the members of the Surviving Corporation, as follows:
